Bizinezi ndi chilichonse chimene munthu amapanga ndi cholina chofuna kupeza phindu. Zochitikazi zitha kukhala monga kugula ndi kugulitsa, ntchito za manja, zaluso ndi ntchito za ukadaulo osiyanasiyana.

Boma la Malawi linakhazikitsa malamulo okhudzana ndi kulembetsa bizinezi (Business Registration Act 2012) omwe amanena kuti mzika ilionse imene ikupanga bizinezi ikuyenera kulembetsa bizineziyo ndi nthambi yoona za kalembra wa bizinezi (Department of Registrar General).

Ndi zopindulitsa kwa mzika ilionse ngati bizinezi yalembetsedwa potsata ndondomeko yokhazikitsidwa. Izi zimateteza ufulu wa mwini bizinezi komanso wa ma kasitomala.





Bizinezi iliyonse imafuna chilolezo cholinganana ndi mtundu wa malonda. Chilolezo chimaperekedwa ndi akulu akulu oyang'anira zochitika mbali imeneyo. Mwachitsanzo mabizinezi azomangamanga amafunika chilolezo kuchokera kubungwe loyang'anira zomangamanga - National Construction Industry Council (NCIC) pomwe wa Lodge amafunika chiphaso chochokera ku bungwe loyang'anira zokopa alendo (Tourism Council).

Kodi chimachitika ndi chiyani mukalembetsa msonkho?

chowerengera chuma chathera. Mwini bizinezi ndi amene amasankha ndondomeko ya chaka chowerengera chuma kapena chaka cha bizinezi.

3. Pamsonkho wowonjezera (VAT), Ndondomeko ya bizinezi ndi tsatanetsatane wa msonkho bizinezi yanu yayendera, ikuyenera kuperekedwa kubungwe lotolera msonkho (MRA) pasanafike pa 25 mwezi otsatira stopped transacting business, it is advisable to notify the MRA for their records and it is expected that the same notice should be given once business operations resume.
